



## POTENTIAL ENGLISH TRACKS IN BAMBERG

Double degree program between the University of Pavia (Master in Economics, Finance and Integration, MEFI, Master in International Business and Entrepreneurship, MIBE and Master Economia e legislazione d'impresa, MELI ) and the University of Bamberg (Master in Business Sciences and Master in Finance and Accounting).

### 1. General Information

Students of both institutions start in the winter semester at the home university and complete the first year of the program there. In the second year, students move to the host university. In Bamberg, students of the University of Pavia who want to study the Bamberg part in English should choose the Master in Business Administration.
