AMENDMENT No 1

TO THE IMPLEMENTATION AGREEMENT TO THE ARTICLES II, III, VI, OF THE MEMORANDUM OF UNDERSTANDING SIGNED BETWEEN THE UNIVERSITY OF ECONOMICS IN BRATISLAVA AND DEPARTMENT OF ECONOMICS AND MANAGEMENT OF THE UNIVERSITY OF PAVIA ON 10.02.2020

(hereinafter the "agreement")

between

(hereinafter "EUBA")

and

DEPARTMENT OF ECONOMICS AND MANAGEMENT OF
THE UNIVERSITY OF PAVIA
(hereinafter "UNIPVDEM"),

I. The Agreement is amended as follows:

In Art. 1 the last sentence reads as follows

- for the EUBA, Master program in FINANCE AND TAXES (hereafter FaT) and Master program in FINANCIAL MARKETS AND INVESTMENT (FMaI).

In Art. 9b the table reads as follows

ECTS required	Details of educational activities
60 ECTS	Courses: 46 ECTS (including State Exam: 10 ECTS) Master thesis: 14 ECTS (seminars and defense)

II. Content of the Annex 1 and 2 has been changed.

III. Other provisions of the Agreement are not affected by this Amendment.

IV. This Amendment becomes legally binding by the day after the day this Amendment being published in the Central register for contracts of the Slovak Republic.
